ACCOMMODATION TAX

From July 1, 2012 the City of Scarlino by resolution of the City Council No. 20 of June 15, 2012, integrated by resolution of the City Council No. 4 of March 15, 2013 , No. 59 of December 29, 2014 and No. 4 of March 31, 2021, has established the "accommodation tax"

The tax is applied to non-residents overnight stays in the city of Scarlino and for a maximum of 10 consecutive nights.

At the end of each stay, the guest pays the tax due to the accommodation manager, who issues the receipt for the amounts collected.

RATES

The tax rates for every kind of accommodation facilities are:

EXEMPTIONS

Are exempted from the payment of the Accomodation Tax:

- a) members of the Register of residents of Scarlino Municipality;
- b) minors under twelve years of age;**
- c) bus drivers and tour guides who provide assistance to groups organised by travel and tourism agencies of minimum 25 participants. The exemption applies to each coach driver and one tour leader for every 25 participants;**
- d) volunteers serving in events organized by Scarlino Municipality, Provincial or Regional Government or for environmental emergencies. For any event, organizers will individuate the operators and the stakeholders;
- e) personnel belonging to the State Police and other armed forces, also members of Fire Department who stay overnight for service requirements;
- f) those who work in the accomodation facilities;
- g) overnight stays during low season, from September 1 to April 30;
- h) overnight stays for study and research purposes, if the project is supported by the Municipality.
